#### MORE ABOUT THE SORORITY PRESENTING THE 2019 YOUTH SYMPOSIUM

The "Motivated" Mu Beta Sigma Chapter is a group of 40 women in Williamson and Bell Counties who thrive on sisterhood, service, and scholarship and most importantly bringing those characteristics to life within our community. We visualize a world in which women and their families reach their fullest potential in every aspect of life and can create unlimited opportunities for our future generations.

In 2014, eight women of North Austin chose to gather and pursue this mission here in Round Rock, Texas to serve the surrounding counties and as result strive to improve the everyday lives of the families in our community. Because of the mission set forth by 7 African American female educators on November 12, 1922 at Butler University we can continue to build by transferring knowledge and information to everyone we meet.

Through our founders Mary Lou Allison, Nannie Mae Gahn, Vivian White, Bessie Downey, Cubena McClure, Dorothy Hanley, and Hattie Mae Dulin found themselves at a predominately white university in the '20's (which only admitted 10 Black students each year) they forged on and quietly began their society for educators seeking to make a difference. In doing so, they indirectly challenged perceived early twentieth-century notions about race and gender. They subtly defied the local KKK when they established their society for college-educated African American women.

Ignoring the commonly held view that African American women were intellectually, culturally, and sexually inferior, the seven founders relied on racial autonomy, community building, and constructive activism to topple racism, poverty, and hopelessness. It is because of the strength they embodied that the MU BETA SIGMA Chapter can achieve Greater Service, Greater Progress.


